Our standard fee for obtaining a Grant of Probate for a non-taxable Estate is as follows:

Full Estate Administration

Our fee for carrying out a Full Estate Administration depends on the size and complexity of the Estate. For a percentage based fee Full Estate Administration:

We charge industry-standard fees of between 1% - 2% of the Estate's value depending on the complexity of the work involved. Given an Estate of a value of £200,000 and of modest complexity, and so a fee of 1.5% of the Estate's value being charged, our fees are calculated as follows:

Transfer of a Deceased Person's Property (Assent):

It is common for property to be transferred to new owners or into Trust during the course of a Probate transaction. Whilst transfers into Trust may require some more complex ancillary work, for which further fees may apply, our standard fees for an Assent are as follows:

VAT: £70.00

There is generally a Land Registry transfer fee as follows:
